JUDGMENT

- In the instant Appeal, the Appellant, M/s. Lakshmi Jalavidyut (Krishna) Limited, Bengaluru, is questioning the legality, validity and proprietary of the common order passed by Karnataka Electricity Regulatory Commission, Bengaluru (1st Respondent herein) dated 09.01.2018 in OP No. 100/2016 and OP No. 47 of 2017.
- 2. The Appellant has sought the following reliefs in DFR No. 5021 of 2018:
 - i. Call for records from 1st Respondent KERC;.
 - ii. Set aside the Order dated 09th January, 2018 passed by 1st Respondent KER in O.P. No.90/2016 filed by Respondent BESCOM and O.P. No. 47/2017 filed by GESCOM produced as Annexure-A1
 - iii. Grant the cost of the Appeal;
 - iv. Pass such other order/s as deemed fit under the facts and circumstances of the present case.
- 4. The learned counsel Mr. Anantha Narayana M.G. appearing for the Appellant at the outset submitted that in view of the judgment/order dated 29th March, 2019 passed by this Tribunal in

Appeal No. 42 of 2018 & IA No. 214 of 2018 in the matter of M/s. Fortune Five Hydel Projects Pvt. Ltd Vs. Karnataka Electricity Regulatory Commission & Ors. and connected matters, the instant Appeal filed by the Appellant may kindly be numbered and disposed of.

The instant Appeal filed by the Appellant is hereby disposed of in terms of above judgment/order dated 29th March, 2019 in Appeal No. 42 of 2018 & IA No. 214 of 2018.
